Carpet cleaning fee of \$75 will be added to the final bill if limousine is left with an excessive mess. Bodily waste cleaning fee is \$200. Cancellations must be made within 10 days of reservation date to avoid responsibility of full rental amount. Our drivers reserve the right to deny and/or evict any person that they feel are contributing to the creation of a problem and/or unsafe condition in the rendering of our services. Shore Limo will not be held responsible for any problem that may develop at the point of destination. We are not responsible for any articles left in the vehicle. There is a charge of \$10 per broken or missing glass belonging to Shore Limo. There is NO SMOKING in any vehicle belonging to Shore Limo. Payment must be made in advance. Virginia State Law prohibits anyone under the age of 21 to possess or consume alcoholic beverages. Unlawfully possessing/drinking alcohol or using any illegal substance is not permitted in the limousine; and if detected, the run will be terminated without refund. If a cancellation of service is made, the deposit that is required to reserve the date will be considered a cancellation fee and will not be refunded.
