Our drivers reserve the right to deny and/or evict any person that they feel are contributing to the creation of a problem and/or unsafe condition in the rendering of our services. Shore Limo will not be held responsible for any problems that may develop at the point of destination. We are not responsible for any articles left in the vehicle. There is a charge of \$10 per broken or missing glass belonging to Shore Limo. There is NO SMOKING in any vehicle of Shore Limos. Payment must be made in advance. Va. State law prohibits anyone under the age of 21 to possess or consume alcoholic beverages. Unlawfully possessing/drinking alcohol or using any illegal substance is not permitted in the limousine; and if detected, the run will be terminated without refund. If a cancellation of service is made, the deposit that is required to reserve a date, will be considered a cancellation fee and not be refunded.
